Session Descriptions

STFM's Annual Spring Conference offers a variety of presentation formats to satisfy differing needs. Here is a brief overview of the types of presentations available for your participation.

Completed Projects and Research

Original research presented on education, process of care, patient-oriented outcomes, and quality of care studies. Multiple presentations are grouped for each 60-minute session.

Lecture-Discussion

Lecture presentation, with specific time set aside for audience interaction and/ or discussion that introduces a curricular, teaching, administration, or faculty development topic. Two 30-minute lecture-discussions are paired for each 60-minute session.

Panel Discussion

An interactive session with a moderator, and two to four expert panelists leading a discussion and/or interactive activity about an innovative or provocative topic in family medicine education. Active audience participation is required. Sessions are 60 minutes.

Scholarly Topic Roundtable Discussion

A roundtable presentation for up to 10 participants sharing ideas, experiences, or projects pertinent to family medicine education, clinical care, research, or management. These 50-minute discussions take place during the continental breakfast in the general session ballroom.

Seminar

An interactive, audience participation session about an innovative educational, administrative, research, career development, or clinical topic. Seminars are 60 minutes.

Works-in-Progress

Brief lecture presentation on an in-progress project related to teaching, education, curricular or clinical intervention, management innovation, or quality improvement. Four 15-minute presentations are grouped for each 60-minute session.

Workshop

Extended, interactive session that provides a task-oriented, small-group educational experience directed toward the acquisition, demonstration, construction, and/or synthesis of specific knowledge, skills, and /or attitudes. Workshops are 90 minutes.

Posters

Posters are displayed for a full day, with 60 minutes of dedicated presentation time. This year's conference continues to provide multiple innovative scholastic poster sessions, allowing for more presenters to share their important work. Presenters will be available during scheduled times to discuss their poster presentations with conference attendees.

Fellow/Resident/Student Research Work in Progress Posters (FP)

These poster presentations illustrate research projects currently in progress, as well as completed projects by clinical or academic family medicine fellows, residents, and students.

Research Posters (RP)

These posters provide an opportunity for one-on-one discussion of investigators' original research.

Scholastic Posters (P)

These posters provide a one-on-one opportunity for the author to present innovative projects in family medicine education, administration, or clinical care.

STFM Behavioral Science/Family Systems Educator Fellowship Program Posters (BP)

This competitive, yearlong fellowship is for family medicine faculty who have responsibility for coordinating or teaching the behavioral science/family systems curriculum in their departments or residencies. These poster presentations are part of the required curriculum for the fellowship.

STFM Emerging Leaders Fellowship Program Posters (FP)

The yearlong Emerging Leaders fellowship offers training, tools, and support for new faculty and those who are transitioning to leadership roles. These poster presentations are part of the required curriculum for the fellowship.

Population Health and Latino Immigrant Patients: Opportunity or Problem?



The standard social determinants of health model (race, income, education, access to care) does not have predictive power with Latino populations. In spite of having higher risk factors (eg low income, education and access to care) than other populations, Latinos have better outcomes in a number of areas (chronic diseases, birth outcomes, smoking, etc.) in a phenomenon known as the Latino Epidemiological Paradox. Immigrant Latinos, who have even worse risk factors (even lower income, education and access) than US-born Latinos, consistently show even better behaviors (lower smoking) and outcomes (lower mortality) than the

US born. The social determinants that do have a negative effect on Latino health include assimilation and acculturation. While the population health mandate offers providers a chance to build upon the healthy behavior of Latino immigrants, current policy, such as the Affordable Care Act, excludes Latino immigrants in general and undocumented in particular, from program participation.

Federal Support for Primary Care Research: The Role of AHRQ



The Agency for Healthcare Research and Quality's (AHRQ) authorization from Congress ties health services research funding to a policy and practice agenda, including a focus on primary care as a foundational component of the health care system. Through its convening, communication, and funding functions, AHRQ has been an organizing voice setting the research direction for the field.

President Trump's 2018 federal budget blueprint includes a proposal to dissolve AHRQ as a freestanding agency within the Department of Health and Human Services and to move its activities to the National Institutes of Health.

This session will be led by a primary care physician who was a previous director of AHRQ. It will include a brief presentation of the agency's historical support for primary care research followed by a moderated discussion on the future of primary care research and whether it might be enhanced or undermined if Congress reorganizes AHRQ.




